Spread the cost of your Regulatory Fees

You can now spread the cost of your Regulatory Fees over ten monthly instalments. Endorsed by the Law Society, the annual programme is run by E B Commercial Finance in conjunction with Premium Credit, a Bank of America company. It continues to be open to individuals and firms to cover all fees due to the SRA.

Individuals and firms of all sizes can make an application to use this programme.

- No individuals are credit searched as part of the application
- No Partner or accounting information is required
- A simple application form is provided overleaf
- No additional information is required

Upon receipt of correct documentation and clearance of your first monthly instalment, payment will be made directly to the SRA on behalf of the individual or firm.

Please note that an application for the programme does not guarantee acceptance and, in the unlikely event that you are not accepted, you will need to ensure full payment is sent to the SRA by the regulatory deadline 31 October 2010.

Applications should be made immediately, and before 27 October 2010 to ensure that payment is received by the SRA by the regulatory deadline 31 October 2010. There is no guarantee that applications made after this deadline will be approved. If you intend to use this facility, please make your application and then notify the SRA by attaching the slip below to your renewal notice when returning it to them.
